**President Report-**

Lift clean and place, etc. Heather and the Rules Committee got together and went through all the rules and eliminated rules that were already covered by USGA or the Antelope Hills Local Rules.

Motion to accept the new rules was made by Jeannie Dew and seconded by Patti Rice. The motion then went to a vote and was passed unanimously.

Discussed different situations but, play the ball as it lies, is the end result unless there are any Abnormal Course Condition. Abnormal Course Conditions are: Animal holes, movable obstructions, temporary water, and ground under repair (must be marked).
