Renewals must be completed by Dec. 20 to be eligible to sign up for ILGA's January activities. Instructions are on the website Members Information page under Membership. The cost is \$125 for a full membership and \$65 for handicap only.

2024 CHIT BALANCES

Chits accrued through Dec. 31, 2024, must be used by Dec. 31, 2025. If you use your chits before December 31, 2024, you will receive an addition 5% off of the normal member discount of 10% on hard goods and 15% on soft goods. Your chits may be used at both Golf Shops and also at Stone and Barrel and Grill on the Green. You can find your chit balance by accessing the IronOaks Resident website and using your homeowner account. If you are having difficulty accessing your account, you can also call the Oakwood Golf Shop to get your chit balance.
